

Cecabul Business Partner Agreement

This Business Partner Agreement (“Agreement”) is entered into on [Effective Date]

BETWEEN

CECABUL AFRICA LTD, a capacity-building and consulting organization, having its principal place of business at Nairobi, hereinafter referred to as “CECABUL”

AND

[Address], hereinafter referred to as “Business Partner” or “CBP.”

1. PURPOSE OF THE AGREEMENT

The purpose of this Agreement is to appoint the Business Partner as an independent revenue-generating partner of Cecabul, responsible for marketing, advertising, lead generation, client acquisition, and fundraising for Cecabul programs and services under a multi-level business partner model.

2. APPOINTMENT & STATUS

2.1 Cecabul hereby appoints the Business Partner as a non-exclusive, independent Business Partner.
2.2 Nothing in this Agreement shall be construed as creating an employer–employee relationship, agency, joint venture, or partnership in law.

3. SCOPE OF FUNCTIONS (CBP MANDATE)

The Business Partner shall:

- Invest in and execute marketing and advertising activities for Cecabul offerings.
- Identify, engage, and sign up individuals, businesses, institutions, NGOs, churches, and organizations as Cecabul clients.
- Mobilize donations, sponsorships, grants, or program funding under the Cecabul brand.
- Represent Cecabul ethically and professionally in all engagements.
- All funds mobilized, including sponsored programs and donations, shall be deemed revenue for commission computation.

4. EXCLUSIONS & LIMITATIONS

The Business Partner shall not:

- Deliver trainings, workshops, coaching, or facilitation under the Cecabul brand.
- Provide training venues, logistics, or operational execution.
- Enter into contracts on behalf of Cecabul without written authorization.
- Modify Cecabul pricing, curriculum, or intellectual property.

5. BUSINESS PARTNER LEVELS & COMMISSIONS

Level Monthly Sales Revenue Commission Rate

- Silver Partner Below USD 2,000 : 15%
- Gold Partner USD 2,000 – USD 4,000: 25%
- Platinum Partner Above USD 4,000: 35%

5.1 Commissions are calculated monthly based on verified revenue received by Cecabul.

5.2 Payment shall be made within 30 days after month-end reconciliation.

5.3 Cecabul reserves the right to audit revenue attribution.

6. BRAND & INTELLECTUAL PROPERTY

6.1 Cecabul retains full ownership of all trademarks, curriculum, frameworks, content, and methodologies.

6.2 CBP is granted a limited, revocable, non-transferable license to use Cecabul branding strictly for approved marketing purposes.

7. CONFIDENTIALITY

The Business Partner shall maintain strict confidentiality regarding Cecabul's proprietary information, pricing, client data, and internal strategies during and after termination.

8. TERM & TERMINATION

8.1 This Agreement shall run for one (1) year, renewable annually.

8.2 Either party may terminate with 30 days' written notice.

8.3 Cecabul may terminate immediately in cases of misconduct, misrepresentation, or brand abuse.

10. GOVERNING LAW


